Crime in Rinn Valley Ranch remains low.

Our Police Department officers report citing drivers for not stopping at the corner of Homestead Drive and Rinn Valley Drive with the 4-way stop. Many drivers continue to be cited on CR 7 between CR 20.5 and Rinn Valley Drive. Don't forget the reduced speed limit in that area.

Several calls have been received for dogs off leash. It is unlawful for dogs to be off leash outside of fenced yards unless completely under control by voice command or remote command.

Several residents have been allowing their dogs to be in public areas of Rinn Valley Ranch off leash and will be cited if reported, unless they meet the law of control. If cited, owners may be required to report to a court hearing and a possible \$1000 fine.

Door to Door solicitors must have a currently dated city permit, on their person, to be produced. Please ask to see this permit. If they cannot produce it to you, the Police Department requests to be notified. Religious groups are exempt from this ordinance.

The Town of Frederick is seeing an increase of fuel theft from vehicles. Please use locking gas caps if vehicles cannot be secured in garages or behind fences. RVR has not had any reports yet, but several other developments are having increasing reports.

Frederick is having many reports of items being stolen from unlocked vehicles, both during daytime and overnight areas. Please remember to keep your cars locked at all times!

Youth curfew remains 12:00AM for those under 18 yrs old.

That's right, instead of lugging your cleanup day items to the Public Works building this year, Waste Connections will pick them up right at your curb! Make sure to have items out by 7:00 a.m. You'll need to have items like branches and carpet cut to less than 4 feet, and tied into 40-pound bundles. Furniture will be accepted. Items that won't be accepted are hazardous materials, batteries, paint, tires, items that are flammable (gas cans, gas grills, etc...) or contain freon, cement, cars and electronics. We hope this new service will add convenience and ease to your spring clean up!

Fireworks violations will be strictly enforced this year! Fireworks must be of the type that remain on the ground. Remember that if they “go up or blow up” they are unlawful in Frederick.
